

# **Qpoint Privacy Policy**

In order to provide the full range of services, Qpoint sometimes need to collect personal data (PD) about you.

This Privacy Policy explains the following:

- What data Qpoint may collect about you;
- how Qpoint will use data collected about you;
- when Qpoint may use your data to contact you or others;
- how Qpoint protects your data;
- whether Qpoint will disclose your data to anyone else;
- your choices regarding the personal data you provide to Qpoint; and
- the use of cookies on the Qpoint website and how you can reject cookies.

Qpoint is committed to safeguarding PD. Whenever you provide PD, Qpoint is legally obliged to use your information in line with all laws concerning the protection of PD, including the Data Protection Act 2018. Qpoint processes your PD to support the delivery of healthcare through the quality assurance of medical devices (Article 61e of the General Data Protection Regulation (GDPR)), or to deliver a service to which you have contracted (Article 61b of GDPR).

What personal information do Qpoint collect from the people that visit the Qpoint website?

When registering for Qpoint services on the website, by telephone or email, you will be asked to provide your full name, email address, postal/work address, phone number, profession, details relating to the Point of Care Testing (POCT) devices you use and other

details to help Qpoint provide you with the full range of services. If you are a 'home user' you will also be asked to provide details of the organisation responsible for your care, this will include their postal/work address, phone number and profession e.g. General Practitioner/Diabetic Specialist Nurse.

#### When do Qpoint collect information?

Qpoint collect information from you when you register for any Qpoint Scheme, submit an enquiry or participate in Qpoint services. A record of any communications you have with Qpoint and all the results you submit to the Qpoint External Quality Assessment Scheme (EQAS) is maintained on the Qpoint database with your PD and will be retained for 10 years from last date of contact, then securely destroyed.

# How does **Qpoint** use your information?

Qpoint may use the data collected from you in the following ways:

- To improve the Qpoint website.
- To efficiently process your registration/enquiry/complaint.
- Evaluate the performance of your device.
- Escalate matters of non-compliance/poor device performance to you or relevant parties.
- To comply with relevant regulatory authority data requests.
- To contact you with relevant information pertaining to your registration.
- To send periodic emails regarding your Qpoint registration.

The results you submit to the Qpoint EQAS are required to assess device performance. Qpoint keep a record of your communications in order to take appropriate follow up action as required to facilitate service delivery.

# If you are a healthcare professional:

Qpoint will have cause for concern if you fail to respond to repeated red light reports andimprove your performance on the scheme, or continually fail to submit results. In such an event your PD, record of your compliance on the Qpoint EQAS (how frequently you return a result) and what scores you achieve may be shared with the manufacturer/distributor of your device, the National Quality Assurance Advisory Panel (NQAAP) within the UK and with any third party to whom you are professionally accountable (e.g. Governance lead, Manager, Coordinator). If you are a healthcare professional that does not practice in the UK, the equivalent overseas bodies may be notified.

#### If you are a home user:

Qpoint will have cause for concern if you fail to respond to repeated red light reports and improve your performance on the scheme, or continually fail to submit results. In such an event your PD, record of your compliance on the Qpoint EQAS (how frequently you return a result) and what scores you achieve will be shared with the manufacturer/distributor of your device and with the nominated organisation responsible for your care. This will enable them to offer assistance should you require it.

## All registered **Qpoint** participants:

The EQA results submitted from all Qpoint participants will be used anonymously within groups of device type to perform statistical analyses and evaluations. These results will be made available within the Qpoint Annual Report and will enable both manufacturers/distributors and Qpoint to improve the quality of their products. They will also be used to aid development of professional standards and help assure clinical effectiveness of POCT devices.

In exceptional circumstances, a regulatory body may require EQA results to be supplied directly to the authority by Qpoint, if this occurs, affected participants will be notified in writing.

How does **Qpoint** protect your information?

The Qpoint website is scanned on a regular basis for security holes and known

vulnerabilities in order to make your visit to the site as safe as possible. It is also scanned

regularly for Malware.

Your PD is contained behind secured networks and is only accessible by a limited number of

persons who have special access rights to such systems, and are required to keep the

information confidential. In addition, all sensitive information you supply is encrypted via

Secure Socket Layer (SSL) technology, with intrusion detection and a web application

firewall.

All data relating to monetary transactions are processed through SagePay, a PCI compliant

company. This information is not held by Qpoint or DCSL Software Ltd.

Does Qpoint use 'cookies'?

Yes. Cookies are small files that a site or its service provider transfers to your computer's

hard drive through your Web browser (if you allow it) that enables the site's or service

provider's systems to recognise your browser and capture and remember certain

information. If you accept, Qpoint may use cookies to gather the following data:

Internet Protocol (IP) address

Date and time of site access

Specific pages you visit within the website

Why does **Qpoint** use cookies?

This information is solely used to compile aggregate data about site traffic and site

interaction to improve site experiences and tools in the future.

You may set your browser to notify you when you receive a cookie or to refuse receiving it.

By changing your browser settings, you can also determine that your browser will not

accept cookies from this website.

If you do not accept the cookies, it will not affect your online experience with Qpoint.



## Third-party disclosure

#### If you are a healthcare professional sponsored by a manufacturer/distributor:

Your name, contact details and device data can be accessed from the Qpoint database by the manufacturer/distributor of your device, with whom Qpoint has a signed confidentiality agreement. This will enable the manufacturer/distributor to offer assistance if your Qpoint reports indicate that you may have a problem with your device. Device data that you have submitted to Qpoint may be shared with device manufacturer/distributors to facilitate financial calculations or statistical analysis. This data is anonymous and is used by the manufacturers/distributors to audit their accounts and improve their products. If Qpoint has any cause for concern with regard to the results you submit to the EQA Scheme or a failure to improve quality, Qpoint are also obliged to give your PD and Qpoint data record to the National Quality Assurance Advisory Panel (NQAAP) within the UK (see "How do Qpoint use your information?") and any third party to whom you are professionally accountable (e.g. Governance lead, Manager, Co-ordinator). If you are a healthcare professional that does not practice in the UK, the equivalent overseas bodies may be notified. Personal details and device data may be infrequently accessed by the United Kingdom Accreditation Service (UKAS) who are required to inspect and audit the Qpoint EQA Scheme, and the software developers (DCSL Software Ltd.) who service and support the Qpoint Software and website. Such employees have a duty to keep any information observed during the course of their work confidential. Your PD will not be passed to any other third parties without obtaining your consent.

## If you are a home user:

Your name, contact details and device data cannot be accessed from the Qpoint database by the manufacturer/distributor of your device but if your Qpoint reports suggest that you require assistance, Qpoint may pass your PD to the manufacturer/distributor of your device with whom Qpoint has a signed confidentiality agreement. Your nominated care organisation may also be informed. This will enable them to offer assistance and assure the quality of your test results. Device data that you have submitted to Qpoint may be shared with device manufacturers/distributors to facilitate financial calculations or statistical

analysis. This data is anonymous and is used by the manufacturers/distributors to audit their accounts and improve their products. Personal details and device data may be infrequently accessed by the United Kingdom Accreditation Service (UKAS) who are required to inspect and audit the Qpoint EQA Scheme, and the software developers (DCSL Software Ltd) who service and support the Qpoint Software and website. Such employees have a duty to keep any information observed during the course of their work confidential. Your personal information will not be passed to any other third parties without obtaining your consent.
